Study Visit to Portugal (Lisbon, Loures, Cascais), 10-11 April 2024

Background information on the project

The EU / CoE Joint Project on “Building an inclusive integration approach in Finland” aims to contribute to the ongoing reform on migrant integration and inclusion in Finland, working with 6 municipalities (Hämeenlinna, Kuopio, Tampere, Turku, Vaasa and Vantaa) on promoting the implementation of local integration strategies which reflect intercultural and good relations principles.

The project aims to support the development and implementation of intercultural integration and good relations policies by the national, regional, and local authorities in Finland, including through coordinated multi-level and multi-stakeholder approaches. Additionally, the project aims to equip local, regional, and national authorities with knowledge and tools for intercultural integration and good relations policy design and implementation.

Aim of the Study Visit

The study visit is being organised to municipalities which are members of the Intercultural Cities (ICC) network in Portugal, a country with expertise and experience in intercultural integration and multi-level, multi-stakeholder governance. The primary objective of this visit is to gain insights into the practical experiences of Portuguese authorities in implementing multi-level governance and the concept of intercultural integration. Furthermore, the visit will enable project stakeholders to gain insights into potential challenges and draw inspiration for their future work.

Expert Profile



As a project and ICC expert, Carla Calado will provide support to the delegation during the study visit, ensuring preparation, organisation, and facilitation of the visit. She has been the Portuguese Intercultural City Network Coordinator since 2018. She has been the chairperson of an NGO and working in the community development field for 20 years. Currently, she provides consultancy services to several organisations. Since 2021, she has led the creation and management of the Portuguese Intercultural Cities cooperative. Recently, she has been working in the diversity and inclusion area, mainly promoting practice-sharing opportunities, delivering trainings and awareness-raising sessions and co-creating tools to foster diversity among employers, through the Portuguese Diversity Charter and the Diversity@Work project, as well as intercultural competence trainings for several public services.
