1. **Universities Fund Kenya (UF)** and selected institutions of **Tampere University of Applied Sciences (TAMK)**, **Häme University of Applied Sciences (HAMK)**, **Jyväskylä University of Applied Sciences (JAMK)**, **Varala Sports Institute (VARALA)**, **Tampere Vocational College Tredu (TREDU)** and **Tampere Adult Education Center (TAKK)** agree to enter this Memorandum of Understanding (hereinafter referred to as MOU), in reference to UF/06/005/05.
2. The purpose of this MOU is to promote and expand international cooperation, commercial activities, stimulate and support educational, professional and intercultural activities and projects of the two institutions, and its respective communities.

This MOU also sets forth the general and specific aspects of the agreement, with the understanding that on the basis of a regular review of activities, the document in both its general and specific content may be revised with mutual consent of both **UF** and selected institutions.

3. General activity areas of mutual interest and concern may include but are not limited to the following:
 - Capacity Building in the university sector
 - Development of Centers of Excellence
 - Community Development
 - Research and Innovation
 - Digitalisation of university education programmes
 - Agriculture/ Food Security
 - Health
 - Smart Climate
 - Renewable Energy
 - Green growth

The form of each cooperation act must be agreed separately by signed agreement of both parties.

4. Institutions understand that this MOU is not exclusive, and each institution is permitted to enter into such agreements as it deems fit with other universities and institutions.

Duration

5. This MOU shall be valid for a period of two years from the date of signature and may be renewed for additional periods by written agreement of the institutions, signed by the duly authorized parties. During the initial two-year term (and subsequent extensions, if any), the parties shall consult at least annually to discuss the program, any problems that have arisen and opportunities for improvement.

Termination

6. Either party may terminate this MOU at any time by giving a written notice 60 days before, signed by the President/Rector of the terminating party.
