## Terms and Conditions

In these terms and conditions "The Company" means TBD Media Group Ltd and "The Client" means the person or company named in this agreement. The "Client Fee" means the amount to be paid by The Client to The Company or representative agent, as set out in this contract.

The "**Production Process**" refers to the delivery of Pre-production, Production and Post-Production

1. The Company will endeavour to perform this agreement and its terms to the best of its abilities.
2. The Client retains approval rights over the editorial content, including story treatment and final edit.
3. The Client is provided with an international copyright license of the final film produced in perpetuity.
4. The Client agrees that this agreement constitutes a non-cancellable contract, governed in accordance with the laws of England and Wales.
5. The Client agrees to pay the Client Fee in full by two equal instalments within 30 days of each invoice date. The 1st invoice for £21,912.50 GBP will be issued at the beginning of the Production Process. The 2nd invoice for £21,912.50 GBP will be issued after approval of the final edit of the film.
6. The Production Process commences within 10 days of the signature of this agreement.
7. The Client is not entitled to withhold payment of any amount due to The Company, by way of set-off or counterclaim.
8. The Client is not entitled to change the payment terms pertaining to this agreement after it has been mutually agreed and signed by The Client. If The Client imposes different payment terms, after signature, The Company will charge an administrative fee of £1,500 for any such changes.
9. Accounts are strictly net of agency commission, unless otherwise stated and are subject to settlement within the payment terms above.
10. If The Client fails to pay The Client Fee for any reason (including failure by The Client to send purchase orders or vendor registration requests upon receipt of the invoice in accordance with clause 5) or any other monies due to The Company hereunder, The Company may charge The Client interest on the overdue amount from the due date up to the date of actual payment, after as well as before judgment calculated on a simple monthly interest rate of two percent (2%) per month. Such interest shall accrue on a daily basis and be compounded weekly.
11. The Client agrees to pay The Client Fee via bank transfer to TBD Media Group Ltd.
12. The Company shall not be liable for loss or damage arising from its failure to perform its obligations hereunder due to force majeure.
13. The Company reserves the right to move the launch date of the campaign in the event of unforeseen delays.
14. The Client agrees that the Production Process must be completed within 90 days from its commencement.
15. The Client is entitled to three rounds of revisions in the edit process. Any additional edits may incur additional fees.
16. The Company reserves the right to use any material created in collaboration with The Client in its own marketing and promotional activities without seeking prior permission from The Client.
17. The Company does not take responsibility for any delays caused by The Client. Any delays could result in unforeseen costs, such as rescheduling, and may incur further fees to The Client.
18. The content of this contract supersedes any previously written or oral matters that may have been noted or discussed in relation to this order.
19. These terms of business shall be governed in accordance with the laws of England and Wales and any dispute arising under these terms of business shall be subject to the jurisdiction of the English Courts.
